2 New Features


The following new features and improvements are added to this version of Votiro SaaS.

2.1 Office 365 - Easy integration


After getting feedback from our sales team and customers to improve our Office 365 integration, we built an amazing new integration to Office 365. With a few clicks, the integration is set. Like magic!






2.2 FileCloud integration

With this integration, we can offer our security product to companies that use FileCloud as part of their file storage platform.






2.3 The new UI – Beta

- Live status









2.3.2 Incidents page







2.4 New Login

The new login page allows customers to sign in using either of two options:

1. Sign in with Votiro credentials. This option is relevant for customer that have setup local users. The customer can enter his local user email address to sign into the Votiro Management console.




2. Sign in with SSO (using corporate credentials). This option is relevant for customers that have integrated Votiro Cloud through SAML. The customer can enter his corporate credentials to sign in Votiro Management console.



2.5 **AWS S3 - Support multiple SQS queues**

Our product now supports multiple AWS SQS queues. In our management console, our customers are able to add and manage their multiple SQS queues.



2.6 Apple iWork file type support

Our product now supports detection of iWork file types. iWork is common to both macOS and iOS.

3 Resolved Issues

The following open issues have been resolved in this latest version release:

- Resolved an issue where original and sanitized files cannot be downloaded/ released
- Resolved an issue where large complex files were blocked due to sanitization
- Resolved an issue where some specific Excel files were detected as unknown
- Resolved an issue where random images in a PDF had the wrong orientation
- Resolved an issue where files cannot be uploaded to the MSSP cluster
