## 1 Introduction

We are very pleased to announce the release of our highly anticipated Votiro Disarmer Suite, version 8.4.

The new Disarmer release contains many improvements, which provide significant impact on the day-to-day workflow for both system administrators and end users.

A major new feature is handing control of password-protected files received as email attachments directly to recipients. Just one recipient manages the sanitization of the attached files, which are added to the email and distributed to all named recipients.

We have again increased the portfolio of file types covered for sanitization by Votiro Disarmer, now including the RAR5 file type.



## 2 New Features

The following new features and improvements are added to this version of the Votiro Disarmer platform.

## 2.1 Password Protected Files Returned by Email

In this release, Votiro Disarmer can now sanitize password-protected files that arrive as email attachments and return them automatically via email.

With our unique user-friendly interface, an email recipient enters the correct password of the password-protected file. The password-protected file is then sent for sanitization. The sanitized file is automatically returned as an attachment to the email and delivered to all named recipients.

The administrator enables this feature through a checkbox in the Management Dashboard.

#### Note

Password-protected files received before installation of Disarmer Version 8.4 cannot be sanitized and returned as an email attachment.

## 2.2 Selecting a Test File for Policy Verification

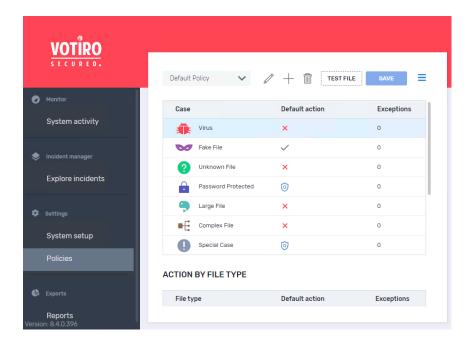
Up until version 8.4, the administrator would manually test any changes made to Policies in the Disarmer installation, including system settings, file processing and sanitization. In this release, a **Test File** option has been added to the Policy page.

When changes have been made to a Policy they can be verified using this feature. By clicking on **Test File** the administrator is presented with a window to navigate and select a file suitable for testing the new Policy settings in the Disarmer environment.

#### Note

The limit for a Test File is 50MB.





2.3 System Language Configuration

You can now configure Votiro Disarmer to have additional language translation, achieving a user interface that matches the language of your organization.

This new feature allows you to translate the Dashboard dictionary. The translation is available for use in the Management Dashboard.

## 2.4 Additional File Type for Sanitization

This release adds RAR5 files to the ever-increasing portfolio of file types Votiro Disarmer can sanitize and safely deliver to your organization.

RAR5 files with password protection are not automatically sanitized in this release.

## 2.5 Editing an API Token

The new feature allowing an API authentication token to be edited, provides you with increased flexibility and security.

## 2.6 Failed Login Protection

Another key security improvement is with the management of multiple failed login attempts to a Votiro Disarmer account in a set time period. When a user provides three incorrect passwords the login account is disabled, preventing further attempts to login for ten minutes.



## 2.7 PDF Remove Remote Access Option

An additional option when defining your sanitization policy for PDF files has been added. The Remove Remote Access option is a checkbox, allowing you to specify whether communication to an external server must be disabled. The default setting is checked.

The following paths for upgrade were tested and approved:

- Upgrade from version 8.3.0.256 to version 8.4
- Upgrade from version 8.3.7.14 to version 8.4
